- 1 the payment of Fees at Fulton School for the Deaf is a statutory obligation, according to the South African School's Act 84 of 1996.
- 2 in terms of the South African Schools Act 84 of 1996 a conditional, partial or total exemption may be applied for, and is only valid in respect of that year. Application for exemption of fees does not absolve one from commencing payment of fees in January 2023, until such time as the exemption is granted by the Governing Body. Exemption applications (Financial Status) forms must be submitted with supporting documentation (salary slips) and lodged with the Financial Administrator before 28 February 2023.
- 3 transport fees are due termly in advance. Should the learner not have a bus coupon, he/she will not be permitted to use the School Bus (where applicable). Legal action can be instituted against me/us should I/we default in payment.
- 4 I/we authorize the School to inform the relevant credit bureau in the event of any school, boarding (where applicable) or transport fees (where applicable) due by me/us not being paid.
- 5 parents are jointly and severally liable for fees and should I/we default I authorize the School to obtain a garnishing order from my/our salaries.
- 6 should I/we default on the agreed payment plan, fees are immediately due in full. I/we will be liable for the Fees and any additional costs incurred on the attorneys /clients behalf, should the fees be handed over.
